

BAIL BOND AGENT REGISTRATION FORM 1/2

Pursuant to §648.42, Florida Statutes, Agents are required to both register and file a certified copy of the surety's power of attorney with the Clerk and Sheriff by April 1st of each odd-numbered year in the county in which the agent resides. The Clerk may not permit registration unless the agent is currently licensed and appointed by the department. An agent may also register in any other county.
