- Certificate to be signed by Circuit Judge, dated and court seal affixed (stamped signature of Judge not acceptable).
- Original certificate to be forward to the Office of Vital Statistics, Delay Unit, P.O. Box 210, Jacksonville, Florida 32231-0042.
- To obtain a supply of this form, submit request on official letterhead to Office of Vital Statistics, P.O. Box 210, Jacksonville, Florida 32231-0042. When ordering, please specify quantity desired.

SAMPLE OF ABSTRACTING

School record, Duval County School Bd. of Public Instruction, Jacksonville, Florida dated September 1, 1940 shows Jane Doe born August 31, 1933 in Miami, Florida to John Doe and Jane Mae Doe.

Official record of Social Security Account # 000-00-0000 dated November 6, 1949 shows Jane Doe born August 31, 1933 in Miami, Florida to John Doe and Jane Mae Doe.

Immunization record, Duval County Health Department, Jacksonville, Florida dated November 5, 1933 shows Jane Doe born August 31, 1933.

Child’s birth certificate filed November 5, 1952 with the Department of Health Atlanta, Georgia shows mother/parent of child as Jane Doe, Age 19 born in Florida.

Insurance record, Prudential Life Insurance Co., Jacksonville, Florida #J00000000 dated August 31, 1935 shows Jane Doe, Age 2, Parent: John Doe.
