Please note that Baker Act and Marchman Act cases are confidential. Photo identification is required to obtain information.

## **PETITIONS**

**Baker Act** (Petition for Ex-Parte Order for Involuntary Examination). This may be filed by anyone (does not require more than one person and they do not have to be related) with firsthand knowledge of the behaviors that are making this person a threat to themselves or someone else. This petition cannot be filed to extend the stay of someone that is already under a Baker Act. This petition is NOT for substance abuse issues. There will be no hearing. The Court will enter an order either granting, or denying, based solely on the information provided by the petitioner. **There are no filing fees**. Petitioner must bring photo ID.

Marchman Act (Petition for Involuntary Assessment and Petition for Involuntary Treatment). For individuals who refuse voluntary treatment for drug and/or alcohol abuse. If the **respondent is an adult**, any individual with firsthand knowledge of the drug and/or alcohol abuse may file. If the **respondent is a minor**, the parent, legal guardian, or licensed service provider may file.

This is a two-step process:

Respondent must be in Hillsborough County.

**Step 1** - Upon filing the Petition for Involuntary Assessment and Stabilization, the Court will direct the Clerk to either set the matter for hearing, issue an Ex-Parte Pick-Up Order to have the Respondent assessed and stabilized without a hearing, or deny the petition based on the petition not meeting the requirements

under the Marchman Act.

Step 2 – Upon completion of the assessment, the service provider will forward the assessment to the

Clerk's Office. The service provider will also contact the petitioner with instruction to return to the Clerk's

Office within 10 days to complete a Petition for Involuntary Treatment.

The Respondent will be served a copy of the petition and assessment and the Court will conduct a hearing

within 5 business days. At the hearing, the Respondent has the right to request legal representation and

continue the hearing for witnesses to testify. If the judge determines that treatment is appropriate or the

Respondent agrees to treatment, the Court will enter an order based on the recommendation. Respondent

must live in Hillsborough County.

**FEES** 

There are no court fees associated with filing a petition. However, fees for treatment will be the

responsibility of the Respondent. If the **Respondent is a juvenile**, the petitioner will be required to provide

assistance in order to follow the court order. PLEASE NOTE: Court Ordered treatment under the

Marchman Act is NOT free. While Providers offer a sliding fee scale, there will be costs associated with

the Marchman Act treatment.
